ORDER:

In the reference 2nd cited, the University has granted the Provisional Affiliation order to **Ragas Dental College & Hospital, 2/102, E.C Road, Uthandi, Chennai – 600 119**, for conducting the BDS Degree Course with an annual intake of 100 seats from the Academic Year 2005-2006.

2. In the reference 3rd cited, the Ragas Dental College & Hospital, Uthandi, Chennai has obtained the recognition order from the Government of India, Ministry of Health & Family Welfare, New Delhi to conduct of BDS Degree Course.

3. As per the Governing Council Resolution No.197 (45) dated.12.05.2010, the above institution was classified under "Once in three years" Category. Hence, the Institution was inspected for grant of Continuance of Provisional Affiliation for the academic year 2017-2018. In the reference 7th cited, the Affiliation Sub-Committee of this University has recommended to the Governing Council to grant Continuance of Provisional Affiliation for the academic years 2018-2019 & 2019-2020, after collecting the necessary fees and obtaining an annual Undertaking regarding teaching and infrastructural facilities. In the reference 8th cited, the Governing Council has approved the recommendations of the Affiliation Sub-Committee.

4. The Chairman, Ragas Dental College & Hospital, Uthandi, Chennai has submitted an annual Undertaking in Non Judicial stamp paper of the value of INR Rs.100/- that the institution possess adequate infrastructural, teaching facilities and other facilities as prescribed by this University for an annual intake of 100 seats for the academic years 2018-2019 & 2019-2020. Further, the Institution has submitted Undertaken to abide by the appropriate rules regarding DTCP approval.

5. The University grants Conditional Continuance of Provisional Affiliation to Ragas Dental College & Hospital, Uthandi, Chennai for conducting B.D.S degree course for the academic years 2018-19 & 2019-2020 as indicated below subject to the usual conditions already intimate in the Provisional Affiliation orders of this University.
